

RETURNING EXPERT PROGRAMME

What is it? A programme to facilitate the return of Malaysian professionals from overseas

OPTIONAL 15%	Optional 15% flat tax rate on chargeable employment income for a period of five (5) consecutive years		
TAX EXEMPTION ON PERSONAL EFFECTS	Tax exemption for all personal effects brought into Malaysia, limited to one (1) shipment		
TAX EXEMPTION ON CAR	 One (1) locally manufactured Complete Knocked Down (CKD) or fully imported Complete Built Up (CBU) car per successful application exempted from duty/taxes up to a maximum of RM150,000 worth of duty/taxes The car must be owned for at least 9 months at time of the REP application The car must be registered under the REP's applicant name The car must be registered in the same country from which the applicant is applying Applicants who decide not to import their car are eligible to purchase a locally manufactured/assembled car in Malaysia 		
TR STATUS FOR FOREIGN SPOUSE AND CHILDREN	 The foreign spouse and children will be eligible for Permanent Resident (PR) status within six (6) months upon receipt of their complete PR application form by the Immigration Department of Malaysia Applicants have to be legally married at time of REP application 		



REP caters to both individual and company applications

APPLICANTS MUST MEET ALL THE CRITERIA BELOW IN ORDER TO BE CONSIDERED FOR APPLICATION





Has not earned employment income in Malaysia continuously for at least 3 years leading to the time of application

Does not hold any outstanding scholarship bond or loan with the Malaysian Government or its agencies

Internal transfer or transfer within same group of companies:

- > Under NO OBLIGATION to return to Malaysia
- Remains an employee of the foreign entity whilst abroad

More holistic assessment criteria which takes into account an applicant's:

- Highest academic qualification
- Working experience abroad
- Working experience in Malaysia (Prior to employment abroad)
- Current salary abroad
- Priority NKEA sector
